Permit Approvals:

9 landlord applications were approved, and 1 solar panel permit approved.

The council agreed to have Jodie approve the other landlord permits just notify them of the ones turned in.

Geri asked how the process will be for those not turning them in. Jodie said she is sending another letter with the ordinance and permit explaining it in more details as a 2nd notice and then we can discuss how to proceed for the ones we do not have by the next meeting.

Staff Reports:

Maintenance Report:

Jodie is to ask David Rush if he would like to take the distributor to his shop to work on it. Steve wants Jodie to check on the breakaway poles for the street signs and let the council know next month the difference. Signs need to be hung straight. Andy from Encore can help with millings when we get ready for streets if needed. Bruce Proctor passed out a sheet from South Central Sealing for prices on slurry for the roads done in 2018 to be resurfaced. Bruce picked a few of them out and it would be around \$20,000 but told the council to go and look and we will revisit the topic.
