## Community/Citizen recognition:

# PRIDE COMMITTEE:

(a) Mayor Semisch introduced Melissa Donham and Kyle Hrabe. Melissa asked Council to rent the port-a-potties for the June 5<sup>th</sup> Block party and then keep them at the park for the duration of the summer. Steve Schuetz made a motion to approve the port-a-potties for 3 months. Bruce Proctor 2<sup>nd</sup>. Motion passed 5-0. Council approved a beer garden for the July 3<sup>rd</sup> celebration in the park. Things the PRIDE committee want to focus on are: Welcome baskets, school supply drive, angel tree, cleaning up citizens yards, in the Fall having a day where they have people get limbs and leaves to the road and the committee helps get them to the limb pile, new and improved Mason sign, and anything that helps bring the community together.

#### **PUBLIC HEARING:**

Jerry Boman: Jennifer requested either the building be completely enclosed, the junk completely gone, or apply for a business enterprise license by the end of June. Jerry Boman said it has been a long time coming and he continues to make improvements. Jerry said he hates to say time frames. The Mayor asked for his plan now. Geri Ebersohl asked about him talking to the PRIDE committee and Darcie Gomez offered to extend it to August and Jerry Boman felt that was reasonable. Darcie said if something comes up then let us know. Bruce Proctor made a motion to approve Resolution 06-2021. Regina Abbott 2<sup>nd</sup>. Resolution adopted 5-0. Jerry Boman was handed the signed Resolution at the meeting.

Danny Jimenez/Mark Mellies: Jennifer Braden presented with facts of having been looking at the property at 114 W. Mechanic St. in June of 2020 but then the original owner passed away. Danny then started moving into that property and in February a Notice of Order was given after a door knocker was ignored. Some major progress has been going on, but the trailer needs to be fixed or gone and the plastic containers need to be stacked neatly and not holding water, the vehicles tagged, and all trash gone. Also, if he is doing this as a business with multiple vehicles then he can do the business enterprise permit. Danny said the trailer is the fire stations and they are supposed to decided if they need it. Danny said if they do not need it, it will go away. He said the water dept. is still picking up their items and the plastic containers do not hold water but are for his trash and when they are full, he dumps them in the back of a truck and hauls them off. Danny is planning on doing more now that Mark has gotten permission from the court since the estate is his now. Steve said he is tired of talking about it and we need to get this done. Bruce Proctor made a motion to adopt Resolution 07-2021 and Resolution 08-2021 to allow 114 W. Mechanic St. until August 31, 2021, to have the property in compliance. Darcie Gomez 2<sup>nd</sup>. Motion passed 5-0. Danny Jimenez was handed the signed Resolutions at the meeting. He was given Mark Mellies since Mark had given him written permission to represent him.

Council agreed that it would be a case-by-case situation. Work session with Wilson Company was scheduled. Jeremiah would like us to write a letter to have the sign pulled out. Council agreed that is between Jeremiah and the Church. The insurance did deny the claim for the Nagel/Wall claim on the water leak.

**Courts Report:** Court went well this month. We did have 2 warrants issued and 1 has already been served. Bruce Proctor made a motion to adopt Resolution 05-2021 to level the property of Tammy Holt trailers. Geri Ebersohl 2<sup>nd</sup>. Motion passed 5-0.

**Law Report:** Chief Howard said the provisional certificates have come back for the two officers to send them to the part-time training at KLETC. Working on our community involvement and getting more active. Jodie let council know that the checks are still done on all the Reserves and the Police hires. Council approved the purchase of 2 bikes for bike patrol.

She showed pictures of Jeff Elliott's to show the progress. She said we are trying to help Robert Shoemaker with his place and is getting the PRIDE committee involved.
