- c) Mayor stated that the council did approve Mayor Kristina Semisch, Jodie Laidler City Clerk, and Geralyn Ebersohl President of the Council to be the designated signers to sign the draw downs for the funds to be released. All those in favor were 5-0.

Staff Reports:

Clerks Report:

Clerks report was discussed.

Meeting procedures: When someone comes before the Council without being on the agenda then the Council will sit and wait and bring it to the next meeting. Budget and spending info was discussed. Permits for sewer and plumbing were reviewed. Steve Schuetz made a motion to make it a practice to not hire any contractors unless they have a Certificate of Liability insurance provided and Workman's Compensation insurance provided. The Council approved the new construction of water and sewer construction with the change of saying the city will charge \$15 for the brass nipple and install the nipple. The City is the only one who takes the nipple out and puts it in. The Council directed the clerk to write a letter to the Library Board asking when they have the meetings, to have a city representative on the Board. The City insurance said we need to require the Treasurer to be bonded and to require a quarterly financial statement from the Library.

Maintenance Report:

Maintenance report was discussed.

Steve Schuetz called about Gick Fleming. Steve asked if we are writing a vacation ordinance to do the street. Steve said he says that is on Gick but Jodie told him that at the last meeting we decided to do it at the meeting, Steve said okay. Discussion about Gick's water line was discussed. Darcie Gomez made a motion to put a meter on Gick Fleming's property with \$400 plus expenses to put a meter in and \$400 plus expenses to put a new one in if the Engineer okay's it. Kyle Hrabe 2nd. Motion carried 5-0.

Information was given to Council about the new KDHE guidelines pertaining to Lead and Copper. They will find out more information at the end of the month when they go to training. Steve said he told Gick he would call him and the clerk will write something up for him to sign. Darcie expressed concern about Council speaking to citizens outside of a meeting and it shouldn't happen. Bruce wants to know if the trash truck is backing down Edwards Dr. Bids were given for road equipment. Council wants to look at the motors before they approve. Tabled for next meeting.

Courts Report:

Court went well this month.

Law Report/ Code Enforcement:

Law report was discussed.

An Officer resigned from Police department and will not be eligible for re-hire, Chief mentioned Russell was under investigation from himself so not sure if that is why he resigned. Officer Bready was terminated and will not be eligible for re-hire. Chief Howard discussed a ride-a-log he is having in case she may be interested in being a Reserve. He also discussed his wife becoming a Reserve or an assistant to Police Admin. He said it is her "job" with him to narrate and she does the formatting of the reports. This way he can have a female and could be a multifunction role and since his wife hears confidential information. Geri asked if his wife would write tickets and he stated she would not. Geri is concerned with circumventing the office and that cannot happen. Darcie asked if she would be unpaid as a Reserve officer and basically be a secretary. Chief said she would help with forms and she is

also a sign language interpreter. He said at some point she may want to write tickets and be on the road but at this point she will just be behind the scene. He said he does not want her to be NCIC trained. He mentioned her helping with KLER and as a civilian she can't go in the back be on KLER. Geri asked if he has gotten in touch with the guy from Harvest Home and Steve said no, he hasn't. He said he has a concern if that guy was doing the weights then would he be able to help if the Sherriff called and needed it.

Council said put the price on the scales for \$5,000 as a bottom dollar and put them on Purple Wave. He spoke about the new Use of Force report. He will continue to check into training. Chief went over the cars and the Vic now has the transmission out and Steve Schuetz said to not fix it. Jodie did say that Jesse did say the car was good. Council said to keep the Vic then if another car goes down, we will fix whichever is cheaper to fix. Chief has said Michael Bryant has expressed interest for a wage increase. He will start looking into grants. Geri did direct the Chief to cover scheduled days that aren't covered especially with Spring Break the days off need to be covered. Geri did ask if the Chief could work the weekends and the Chief agreed to split the time up and have coverage. Council agreed.

Darcie Gomez made a motion to accept the Proclamation for Severe weather. Geri Ebersohl 2nd. Motion carried 5-0.

Darcie Gomez made a motion to accept the Proclamation for Child Abuse Month. Geri Ebersohl 2nd. Motion carried 5-0.

Darcie Gomez made a motion to accept the Code of ethics, mission statement, and value statement. Geri Ebersohl 2nd. Motion carried 5-0.

Kyle Hrabe made a motion to approve after Darcie checks on the formal letter for the Mayor to sign saying we will not enforce the portion of the UPOC book pertaining to voting. Geri Ebersohl 2nd. Motion passed 5-0. Security cameras were tabled to next month.
