#### Council:

The council would like the clerk to make a post about lids on the trash cans to help with the scattering of items and to contact our Refuse contractor to ask their employees to be gentler with our citizens' trash cans. The council also discussed Sydney Scribner's concerns via her email and the Mayor and council agreed our codes and practices are there to protect everyone and will continue. The Mayor communicated the policy of contacting citizens and to remember to remind everyone they can come to a council meeting to express their concerns. The clerk will check with the League of Municipalities to see if we can do an out of the office return for email and not break KOMA doing so.
