## **RESOLUTION 08-2024**

WHEREAS, the City of Leon, Kansas, has determined that this property has an exterior condition (yard) and (structure), primary and accessory, that is deteriorated, dilapidated, and unsightly that exist upon the following described real estate as defined in the Code of the City, Section 8-608 and 8-101: 201 N. Olive St.

WHEREAS the owner, Donald & Geraldine Aragon, was notified of such by the City in writing numerous times since 2022 and failed to fully abate the conditions as requested;

WHEREAS the owner, Donald & Geraldine Aragon, has been cited as the owner and seen by the Prosecuting attorney for the City of Leon, Ks. and has been charged fines.

WHEREAS the Designated Code Enforcement/Public Officer, Geri Ebersohl, determined the property to be deteriorated, dilapidated, and unsightly on October 2, 2023.

WHEREAS the owner, Donald & Geraldine Aragon, was sent notification by certified mail on August 11, 2023, of the city's designation of the property as an exterior condition (yard) and (structure), primary and accessory, that is deteriorated, dilapidated, and unsightly.

WHEREAS the owner, Donald & Geraldine Aragon, accepted receipt of certified mail on August 18, 2023.

WHEREAS the owner, Donald & Geraldine Aragon has made no attempt to contact the city or to correct the conditions which still exists.

WHEREAS the owner, Donald & Geraldine Aragon will be attempted to notified by certified mail service giving Donald & Geraldine Aragon thirty (30) days after being served, to alleviate the conditions or the City of Leon will.

WHEREAS the City will also publish this Resolution in the Butler County Times Gazette for two (2) consecutive weeks since the owner Donald & Geraldine Aragon has been difficult to communicate with in the past.

WHEREAS the City will also publish the Resolution on the City website (<a href="www.cityofleon.org">www.cityofleon.org</a>) as it is designated the official paper of the City of Leon.

WHEREAS the City will also post this Resolution on the premises of both exterior structures where the conditions exist.

WHEREAS if the owner, Donald & Geraldine Aragon, has failed to abate the deteriorated, dilapidated, and unsightly conditions within the thirty (30) days after service or publication as allotted the City will proceed as stated in the City Code.

WHEREAS the City of Leon Code allows in addition to or as an alternative to prosecution, the Code enforcement officer/Public officer to pursue abatement of the violation by adoption of a

resolution authorizing the City to abate the conditions at the end of ten (10) days after the personal service of the owner and/or at the end of ten (10) business days after passage of the resolution, but as an alternative the City of Leon is allowing thirty (30) calendar days to alleviate the conditions.

THEREFORE, be it resolved by the Governing Body of the City of Leon, Kansas, that the City demolish the

structures on the property, improve the premises to eliminate the conditions, place a lien upon the property for the costs of the demolition and that the city clerk certify such costs to the county clerk for assessment to the property taxes of the described property if the conditions are not alleviated within the thirty (30) calendar days as stated in this Resolution.
